SECTION 1

1. Purpose & Credential Scope

1.1 This manual establishes the protocols, security standards, eligibility verifications, and operational guidelines governing the issuance of the AIDMJCCA Press ID Card and Media Accreditation Kit.

1.2 The AIDMJCCA Press ID serves exclusively as an organizational credential to authenticate active practitioners of digital journalism, ground reporting, and verified content creation across India.

2. Statutory Legal Disclaimer & Limitations



STATUTORY PRESS ID NOTICE

The AIDMJCCA Press ID is an internal professional credential. It does not constitute government accreditation, statutory press authority, or executive immunity from law enforcement.

- **No Special Privileges:** The Press ID does not grant toll tax exemptions, VIP access, restricted zone entry, or police checkpoint bypass.
- **Non-Transferable:** Credentials remain strictly personal and must not be loaned, transferred, or duplicated under any circumstances.
- **Legal Ownership:** The physical and digital card remains the institutional property of AIDMJCCA and must be surrendered upon membership cessation.

3. Verification Stages & Required Documents

Prior to card generation, all applicants must clear three distinct verification gates:

Verification Gate	Mandatory Evidence	Scrutiny Body	Processing Window
Gate 1: Identity & Address	Government Photo ID, Address Proof, Passport Photo	Automated / Central Helpdesk	24–48 Hours
Gate 2: Professional Proof	Active Channel Links, Published Bylines, Media Portal URLs	District / State Screening Board	3–5 Working Days
Gate 3: Ethics Compliance	Signed Code of Ethics Declaration, Background Check	National Legal & Credentials Cell	Final Approval

SECTION 4

4. Card Security & Dynamic QR Validation

- **Encrypted Dynamic QR Code:** Every physical and digital card contains an encrypted QR code leading to the real-time centralized verification URL (aidmjcca.org/verify/[ID]).
- **Holographic Micro-Print:** Official physical PVC cards feature anti-counterfeit security seals and high-resolution micro-lettering.
- **Instant Suspension Flag:** In case of disciplinary action, the QR verification endpoint instantly displays an “Inactive / Suspended” status to authorities and the public.

SECTION 5

5. Misuse, Revocation & Penal Actions

5.1 Grounds for Immediate Revocation: Using the card for extortion, issuing threats, carrying unauthorized vehicle stickers (e.g., "POLICE" or fake "GOVT PRESS"), or spreading hate speech.

5.2 Legal Redressal: In cases of serious impersonation, fraud, or criminal extortion under the guise of AIMDJCCA accreditation, the Association will initiate statutory FIR filings under relevant sections of the Indian Penal Code / Bharatiya Nyaya Sanhita.
